NOTICE OF RACE

1 RULES

The series will be governed by the rules as defined in The Racing Rules of Sailing.

2 ELIGIBILITY AND ENTRY

2.1 The series are open to all boats of the Pultneyville Yacht Club & Pultneyville Mariners.

2.2 This will be a single fleet, combined spinnaker and non-spinnaker fleet.

2.3 A PYC member is recommended to be on board any racing yacht, however exceptions can be allowed at the discretion of the fleet captain

3 FEES & REGISTRATION

3.1 There are no fees required for this race

4 SCHEDULE

Dates of racing: **7/6/2019**

There will be a skipper's meeting in the pavilion at: **9:00AM**

The scheduled time of the warning signal for the race is **10:00 AM**

5 MEASUREMENTS

Each boat shall have a valid PHRF-LO certificate.

(OR)

Each boat shall produce a valid measurement rating certificate.

Approved by the Fleet Captain.

6 SAILING INSTRUCTIONS

The sailing instructions will be available on or before Jun 24th 2017 at Pultneyville Yacht Club Website & The Pultneyville Yacht Club.

7 VENUE

7.1 This is a club long distance race and will utilize the waters of Lake Ontario beyond the fixed mark race course.

8 THE COURSES

We will be racing to the mid lake weather buoy (43.621 N 77.406 W (43°37'15" N 77°24'23" W)).25.6 NM Northwest of PYC. Attached is a link to the National Weather Buoy website which includes a picture of the buoy.

9 PENALTY SYSTEM

9.1 The penalties are as follows: Rule 44.1 & 44.2 is in effect.

10 SCORING

10.1 The Low Point System of Appendix A will apply.

11 RADIO COMMUNICATIONS

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones & portable internet devices.

12 PRIZES

Flags will be awarded for 1st, 2nd and 3rd place finishers.

13 DISCLAIMER OF LIABILITY

Competitors participate in the series entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the series.

14 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance.
